Council Board Meets to Celebrate 2015 Successes, Commit to Initiatives for 2016 and Beyond

On December 10, the Council's Board of Directors convened for its final meeting of 2015. Council staff, senior leaders, and Board members engaged in a terrific discussion about the Council's data-driven job growth and economic competitiveness agenda for Massachusetts that is taking shape for 2016–2018. Much of that agenda is being informed by MATTERS and the increasing traction and impact this unique competitiveness benchmarking tool is having among a growing number of policymakers and other key stakeholders.

Board members expressed concern about the potential negative impacts of a proposed constitutional amendment that would impose a graduated income tax, particularly its direct impact on the founders of job-creating

Thomas Glynn was appointed by the MassPort Board on September 20, 2012 to serve as the Authority's Chief Executive Officer and Executive Director, overseeing Boston Logan International Airport, the public container and cruise terminals in the Port of Boston, Hanscom Field, Worcester Regional Airport and real estate holdings in the metropolitan Boston area. The Board reaffirmed the Council's historic and current leadership role in

public education reform, including current efforts to increase access to charter public schools by creating a permanent "growth cap" to provide sustained access to these effective public education models to 37,000 families on public charter school wait lists. At the Board's request, the Council will convene a special directors meeting to discuss charter



schools on January 21 featuring Massachusetts Secretary of Education Jim Peyser, and Council member Paul Grogan from the Boston Foundation.

Congress Votes to Suspend Medical Device Tax, Make R&D Credit Permanent

Last week, Congress advanced a long-debated package of budget bills and so-called "tax extender" legislation. Importantly, the package makes permanent the federal R&D tax credit and includes a two-year suspension of the tax on medical devices imposed by the Affordable Care Act.

The approval of the two-year suspension reflects a growing bipartisan appreciation for the negative impacts the tax will have on research and innovation, impacts that will have particularly severe consequences for some of Massachusetts' most innovative companies and largest employers.

Congress' action this week is overdue and we urge Congress to complete the job and repeal the tax on medical devices completely.

The Council commends Representatives Capuano, Clark, Keating, Lynch, McGovern, Moulton and Neal for their support for the extender package. You can read the Council's statement on medical device tax suspension and repeal here.

International travel provides \$1 billion annually to the

- Since 1975 there has been a 200% increase in passengers at Logan Airport.
- More Logan travelers use public transportation, buses, vans and other High Occupancy Vehicle modes than anywhere in the country.
- Demand for parking at Logan exceeded supply in 36 of 52 weeks last year.
- Logan Airport is the only airport in the US that operates with a parking freeze.
- Parking freezes were enacted in both Downtown Boston and Cambridge in 1973 and 1976 respectively, and Massachusetts is the only state in the nation to limit parking spaces as part of its environmental protection State Implementation Plan.
